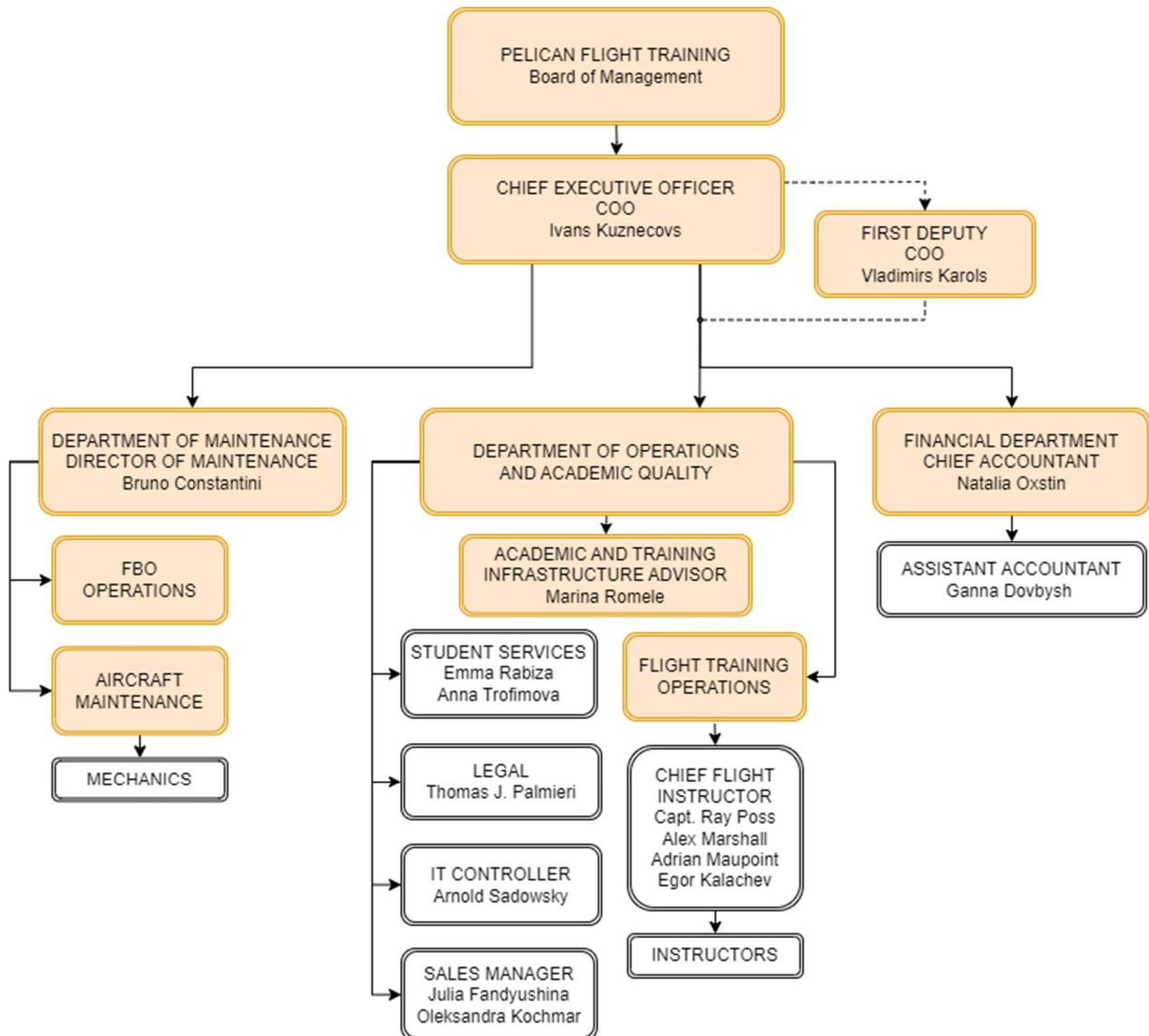

SCHOOL PHILOSOPHY

The purpose of the school is to build a foundation of excellence and to be the preferred source of education by guaranteeing competent graduates. The school strives to produce competent graduates who can succeed at their next level of endeavor in an ever-changing, richly diverse society.

The school will provide a well-balanced curriculum, in an environment conducive to learning and delivered by a highly qualified staff with an uncompromised commitment to excellence. The school recognizes its responsibility to student learning and to instructional staff improvement.

It was this philosophy, which prompted the formation of Pelican Flight Training in 1985 for the purpose of offering professional pilots initial and recurrent training to keep their proficiency at the highest level. At Pelican, this approach is applied to the area of primary and advanced flight training. The aim of Pelican is excellence in pilot training, to give its students the best possible practical program of instruction, and instill in the student an appreciation of the qualities of professionalism, command and airmanship.

Pelican recognizes that the professional pilot should strive to maintain a high level of proficiency and a high sense of safety responsibility that the general public rightfully expects. The profile of the professional pilot is one reflecting a good stature, personality, confidence in character with self-discipline and a mature sense of responsibility. The practical elements of command in the cockpit of today's sophisticated transport aircraft require detailed knowledge of aeronautical theory and procedures, decisiveness in decision making, the capacity to communicate effectively and the discipline to firmly control and utilize all available resources.

In addition to aircraft pilot training for individual students, Pelican offers the professional pilots program to the aviation industry, which must ensure a steady flow of qualified first officer pilots. The professional program is designed to achieve four primary goals:

<ol style="list-style-type: none"> 1) To provide a solid fundamental aviation background through ground school, simulator and flight training; 2) To instill in the student the vital concepts of stability, integrity and command presence so essential to being an airline captain; 3) To measure the student's motivation, adaptability, discipline and reaction to pressure and normal stress of flight; 4) To instill high standards of proficiency and safety in all those pilots who attend. <h2>PILOT TRAINING PROGRAMS</h2> <p>All programs are subject to Federal Aviation Administration Part 141 Regulations.</p> <p>"Ab-Initio" training services are offered to individuals and participating international air carriers for the development of well-trained first officer pilot candidates to serve as air crews on transport category aircraft. The programs are also open groups through the sponsorship of an airline, government or corporation. All courses leading to an FAA certificate or rating consist of academic classroom lecture (ground school) and practical training in an aircraft. Instruction is also provided in approved ground trainers (simulators) when applicable to the flight course.</p> <p>Pilots are permitted to operate aircraft within the limits established under United States and International law after they have qualified for the issuance of a pilot certificate by the U.S. Federal Aviation Administration (FAA).</p> <p>The pilot training programs offered by Pelican provide students with the opportunity to develop flying skills and attain pilot subject knowledge as required by law. Upon successful completion of each appropriate area of ground and flight instruction, the student is recommended for the applicable FAA pilot certification tests. Each pilot applicant must, in the judgment of the instructor and Pelican, demonstrate through testing the skills for each license as promulgated by the FAA. The student must also accumulate the minimum hours of flight experience or instruction as established by Federal Aviation Regulations before undertaking the appropriate FAA examination to earn a pilot certificate.</p> <p>Pelican offers aircraft pilot training courses which include Private, Commercial, Instrument, Multi Engine, Initial Flight Instructor, Instrument Flight Instructor and Multi-Engine Flight Instructor. Separate courses comprise and represent building blocks/ modules of accredited Professional Pilot Diploma Programs.</p> <p>All instruction and training charges are in terms of block hours for flight and simulator, and clock hours for ground school.</p> <h2>HISTORY</h2> <p>In recognition of the aviation industry's need for the supply of professional pilots and the need for continuous refresher training and instruction in new safety techniques, Pelican Flight Training, Inc. began operations at North Perry Airport in South Florida in 1985 as a Federal Aviation Administration Part 61 school. <p>1987, The Federal Aviation Administration granted the school authorization to conduct training under Federal Regulations part 141.</p> <p>The management of Pelican Flight Training has a wealth of experience in aviation behind them, years of experience in teaching and airline management, and thousands of hours of flying. They are thus uniquely equipped to provide those who have chosen to take up a flying career with a breadth of knowledge few other private schools can match. An informal atmosphere provides a pleasant environment in which the student is encouraged to expand their horizons beyond merely meeting government requirements. The management of Pelican Flight Training is acutely aware that a flight training school should be both a service to the public and potential recruiting ground for the airlines. To achieve and maintain this high standard of service, the quality of staff is a key factor in establishing a good reputation and building confidence both inside and outside the aviation community.</p> <p>Pelican looks forward to future growth to meet the on-going demand for career-oriented, professional pilot training services.</p> <h2>LOCATION</h2> <p>Pelican, located at North Perry airport in Pembroke Pines FL, is equidistant from Miami and Fort Lauderdale and is conveniently close to Interstate 95 and the Florida Turnpike with direct access to Orlando and the Keys. And of course, 50 miles off the east coast, lie the islands of the Bahamas. The land is level with near sea level elevations for many miles inland. The endless beaches on the Atlantic Ocean and the warm tropical climate make South Florida a popular vacation place. Abundant recreation facilities are close at hand for the outdoor enthusiast. Many tourist attractions, such as Disney World, Universal Studios, Cape Kennedy Space Center, and the Florida Keys are within easy driving distance.</p> <p>Hollywood is the home of the Florida Marlins major league baseball team and the Florida Dolphins major league football team at the pro-player stadium which is situated 3 miles from Pelican.</p> <h2>TEMPERATURE AND CLIMATE</h2> <p>The average annual temperature is 72.5 degrees Fahrenheit. The average for July is 83.1 degrees F and the average for January is 61.9 degrees F. In general, the climate is sub-tropical with rain showers common in the summer. The average annual rainfall is 51.3 inches and clear mild days predominate in the winter months.</p> <h2>SCHOOL AND FACILITIES</h2> <p>Pelican is located at North Perry Airport within the city limits of Pembroke Pines. It is a short two miles by road to the central business district.</p> <p>All facilities of Pelican are for the use of Pelican pilot trainees. Pelican facilities are housed in four buildings. The flight simulators and student briefing rooms are housed in the Utility Hangar. The airplanes are parked on</p>

<p>the ramp area next to Pelican Administration Building, and inside the Big Hangar. The South Building contains several lecture and briefing rooms. The fixed-wing fleet consists of Cessna 172, Cessna 152, Piper Arrow and Piper Seminole. Pelican's helicopter fleet consists of Schweizer 300c's.</p> <p>The administration building houses the administration staff, flight dispatch, and weather briefing/flight planning area. The building also includes a pilot lounge area, a library and a pilot shop. A real time weather radar system is also available for the students to use.</p> <p>Instruction is carried out mainly on an individual basis. However, where lectures are conducted in the main lecture room, the maximum number of students per class will not exceed 18 students.</p> <p>Program outlines indicate the class size and the number of students in each individual program.</p> <p>North Perry Airport, for the most part, serves small general aviation operations. The airport has four 3050-ft hard surfaced runways with Visual Approach Slope Indicator (VASI) lighting aids for the main runways, and a GPS instrument approach to runway 9R. Air traffic control is provided by an FAA Control Tower. There are VOR/DME and ADF instrument approaches at the local airports of Opa Locka, Fort Lauderdale, Miami and Palm Beach and a computer link connects Pelican Flight Operations desk with FAA Flight Service for weather briefing services and flight planning.</p> <h2>SCHOOL AFFILIATIONS</h2> <p>Federal Aviation Administration under Federal Aviation Regulation Part 141 U.S. Citizenship and Immigration Services for non-immigration student training United States of America, Aircraft Owner's and Pilot's Association, Professional Pilot Programs "A" and "H" are accredited by the Accrediting Commission of Career Schools and Colleges (ACCSC).</p> <h2>INTERNATIONAL STUDENTS</h2> <p>International students come to the United States to seek the educational and cultural exchange experience gained through the user-friendly aviation training systems and the American way of life.</p> <p>Pelican is authorized under U.S. Federal Law to issue I-20 forms and enroll nonimmigrant alien students for F-1 and M-1 visa classifications. This is available for international applicants who meet all enrolment prerequisites and provide evidence of having completed at least U.S. High School or foreign equivalent, which is to be approved by U.S. government licensed evaluators. Applicants must provide proof of financial ability to pay all education expenses and personal support while in the United States and provide proof of English language proficiency. Any documents provided which are in a language other than English must include an English translation certified in a way, which comply with School's requirements.</p> <p>Foreign students holding U.S. Student Visas are recommended to have medical insurance, which can be arranged through Pelican at the student's expense.</p>

<p>Specific rules and conditions apply to each student who is not a U.S. citizen or resident alien of the United States. School Rules for Non-Immigrant Students, and U.S. Federal law governs the conditions of attendance. Full time attendance and participation in training is required, which means attending at least twenty clock hours per week.</p> <p>TOEFL</p> <p>The TOEFL (Test of English as a Foreign Language) exam, or equivalent, may be required as an entrance prerequisite for non-English speaking (foreign) students as a demonstration of English language proficiency. A score of at least 550 on the exam is required prior to being accepted for enrolment. A TOEFL Bulletin of Information can be obtained by writing to your local U.S. Embassy.</p> <p>Students may also demonstrate English language proficiency in three other ways:</p> <ol style="list-style-type: none"> 1) a certificate of English language proficiency from a school; 2) an assessment interview by Pelican Flight Training personnel prior to admission; 3) by already possessing a U.S. FAA Pilot Certificate with no limitations or restrictions. <p>FACULTY</p> <p>Each instructor undergoes rigorous school standardization, and is continuously evaluated and scrutinized by the school to ensure students receive the best training possible. All instructors hold Federal Aviation Administration Certified Flight Instructor certificates.</p> <p>RELEASE OF STUDENT INFORMATION</p> <p>Pelican assures the confidentiality of student educational records in accordance with the Family Educational Rights and Privacy Act of 1974, known as the Buckley Amendment.</p> <p>In general, present and former students have the right to personally review their educational records for information contained and to determine their accuracy. Parents of dependent students have the same rights. Acceptable identification will be required before access is granted.</p> <p>In general, the written consent of the student is required for the disclosure or publication of any information which is (a) personally identifiable to the student and (b) a part of the educational record. However, certain exceptions to that generality, both in types of information which can be disclosed and in access to that information, are allowed within the regulations of the Family Educational Rights and Privacy Act, as described in the following paragraphs:</p> <ol style="list-style-type: none"> A. STUDENT SERVICES

GENERAL DESCRIPTION OF STUDENT ASSISTANCE

The offices of the Student Services, Chief Operating Officer, Chief Pilot, other administrative personnel or any of the Instructors are places where students may go for help at any time. Although all staff members are available to assist students in the resolution of day-to-day problems encountered while attending Pelican, the officers noted above are often in the best position to advise students.

Pelican provides reasonable student support services and has a dedicated Student Services Consultant, who provides informational support to students in the following areas:

- Admission services and visa support;
- Lodging and student life;
- Personal finance planning, budgeting and assistance in opening bank accounts;
- Transportation, health and child daycare-related assistance;
- Advising on training programs, the structure of testing and tutoring;
- Processing of leaves of absence and consulting on attendance policies;
- Providing information on student activities and organizations;
- Overall safety instructions and students well-being;
- Providing overall guidance on possibilities to obtain student financial assistance;
- Providing overall guidance on potential employment opportunities;
- General personal development and soft skills;
- Student retention approaches; and
- Student safety and well-being.

Upon enrollment, students are informed of possibilities to be provided with these supporting services and introduced to the Student Services Consultant. Student Services Consultant also provides initial admission services to prospective students before enrolment (e.g. advising on PFT programs, admission requirements, academic process, costs and payment methods, collecting documents necessary for admission, guiding the applicant through the admission process, assistance in obtaining U.S. visa to foreign students, etc.).

PFT does not provide career counselling, however, can provide students with necessary information on potential employment opportunities.

PFT can provide limited lodging to students and advises students on ways of arranging accommodation through other means.

Students are being informed on the functioning of the public transport system, health care system and child daycare opportunities. PFT can assist foreign students in obtaining health insurance.

PFT does not arrange student financial assistance however can provide students with information on the sources of financing available. Also, the Student Services Consultant can provide general guidance on ways to optimize personal finance and budget

STUDENT COMPLAINTS & CONCERNS

Students who have a complaint or concerns should contact any of the Pelican officials listed in the previous paragraph. If the problem is not resolved the student needs to complete the Student Complaint Form available at Student Services and submit one copy to the Chief Flight Instructor or the Chief Operational Officer, depending on the nature of the complaint, and another copy to Student Services for action to be taken.

The action taken will be documented and a written response will be provided to the student by Student Services no later than within 15 working days from the date of submission of the complaint. One copy of the response will be given to the student and another copy will remain on file with Student Services.

In case the student feels the matter has not been satisfactorily resolved, the student may file a complaint with the Accrediting Commission of Career Schools and Colleges (see the "Student Complaint Procedure" section below). A student is not required to complete the school's internal complaint process before filing a complaint with ACCSC.

Students wishing assistance of any kind or having any questions are encouraged to ask for help at any time. All members of the staff are available to assist.

HANDICAPPED STUDENTS

Medical certification rules of the Federal Aviation Administration govern the participation of disabled or handicapped persons in flying. Limitations to pilot certification under the law do exist, and any student with a handicap or known medical deficiency should consult the Federal Aviation Administration, Aero Medical Certification Branch, P.O. Box 25082, Oklahoma City, Oklahoma 73125, or a designated FAA medical examiner in their community.

INTERNATIONAL STUDENTS

Pelican is authorized under Federal law to enroll non-immigrant students. The Student Services office arranges for the orientation of newly arrived international students. Housing, transportation and general directory information assistance is offered, as well as advice on any other personal matter that may be perplexing to the newly arrived student. To further simplify the difficulties posed by a new and possibly very different environment, Pelican on request will introduce new arrivals to other students of similar cultural background or sharing common language who have been in attendance at Pelican and therefore, may be more familiar with the local community.

ENGLISH INSTRUCTION

Since proficiency in the English language is important to overall success, any student who experiences difficulty with English, after an initial period of adjustment, will be referred to an English language school. Pelican does not provide English instruction. The nearest language schools within the state of Florida are in Miami and Fort

Lauderdale. These schools operate independently of Pelican and may issue an I-20 student visa form to non-resident students.

MEDICAL CARE

Pelican does not offer direct medical care to students. Complete health care facilities are available in the community of Hollywood and Pembroke Pines. These include ambulance services, hospitals, personal physicians and clinics.

Pelican will refer students who seek advice to doctors and dentists. In case of serious illness, parents or spouse will be notified. Payment for medical treatment is a personal obligation at the expense of the student, parent or sponsor.

FAA medical examinations required for pilot certification may be scheduled through Pelican.

STUDENT MAIL

Student mail is received through the U.S. Post Office, Pembroke Pines. Mail is received at Pelican daily, except Sundays and public holidays, and is ready for distribution at the front office desk at 12:00 daily. TRAINING: GENERAL INFORMATION

The curriculum offered by Pelican consists of structured courses leading to basic qualification as a professional pilot and additional ratings. All training is conducted in clock hours, one clock hour equals 60 minutes.

ADMISSION REQUIREMENTS & PROCEDURES

To apply for admission, applicants will complete the application for enrolment and an enrolment agreement. Applicants must meet the Federal Aviation Administration minimum standards as outlined in the code of regulations and stated in each program. The school will then review the applications and notify the applicants in writing whether they have been accepted. Law establishes criteria such as age, medical condition and English language proficiency; prerequisites vary and are listed for each certificate in the Program Description Section of this Catalog.

An application may be obtained by writing to Pelican Flight Training, 1601 SW 75 Ave, Pembroke Pines, Florida 33023.

Following are specific admission requirements, which must be accomplished:

1. Age

All applicants must be at least 18 years of age.

2. Education

All students must be able to read, speak, write, and understand English and have a U.S. high school diploma or equivalent. Foreign diplomas will be translated and verified with certified U.S. evaluators through Pelican at students' costs.

3. Medical Certificate

Although possessing an FAA Medical Certificate is not an admission requirement, the prospective student needs to be aware that he/she will need to obtain the Medical Certificate of appropriate level before making the first individual (solo) flight.

The nearest FAA office can supply a listing of medical examiners in the area and Pelican will assist in arranging an examination with the local FAA medical examiner.

DRUG SCREENING

Pelican Flight Training reserves the right to require a "random" drug screening analysis for any student when reasonable cause exists. This policy is designed to ensure that the highest possible standards of safety and professionalism are maintained at Pelican.

FAA EXAMINATIONS

GENERAL INFORMATION

Pelican currently uses the capacities of outside testing centers for the students to conduct all the examinations listed in the Federal Aviation Regulations. All FAR Part 141 Ground School students will be scheduled for the applicable computer exam as soon as possible following successful completion of Pelican end-of-program test.

A testing fee will be charged to the student's account for each computer exam administered. Failure to report at the scheduled date/time will result in the student's account being debited. Should mitigating and/or extenuating circumstances preclude reporting as scheduled and if proper notification is given, the no-show fee may be excused on a case-by-case basis.

PROCEDURE

Students arriving for testing must bring with them some form of personal identification that shows name, date of birth, signature, and picture (driver's license, passport, etc.). Exams will not be administered without proper identification being presented to the exam monitor prior to the start of the exam. In addition to the above documentation, a PFT program completion endorsement must also be presented to the exam monitor prior to exam administration.

Examinations via the computer medium are uncomplicated and provide more timely results. Instructions given by the exam monitor prior to testing will be more than adequate to allow students to answer, review or change any selection(s) student desires during the exam and prior to grading.

Students are permitted to use the normal "tools" (plotter, calculator, flight computer) during this exam – just as you would for a regular written type exam. However, hand-held programmable computers must have all "memory" data erased prior to beginning the exam.

It is suggested that each student reviews FAR 61.37 (regarding cheating and unauthorized assistance) prior to reporting for his/her examination.

STUDENT PROGRESS POLICY

GENERAL

The purpose of the Satisfactory Progress Policy is to establish criteria to objectively evaluate the student's progress toward his/her educational objectives at this school. Since Pelican is an FAA FAR Part 141 approved school, we are required to follow FAA regulations regarding performance standards and grading, as a minimum. To these minimum standards, Pelican has added its own standards which far exceed FAA minimums. These, as well as the FAA standards, are described in this section.

GRADING SYSTEM

a. Ground School Instruction

Number percentage grades are assigned for all ground school written test and examinations. Grades will also be designated as follows:

Percentage score.....	Grade points
100% to 90%	4
89% to 80%	3
79% to 70%	2

b. Flight Training

Evaluation of student ability to perform individual maneuvers or tasks, as well as overall progress, will be recorded in a flight training record following each instructional period. The grade will reflect the student's overall level of demonstrated ability relative to the ability expected of the average student at the same stage of training or experience or as stated in the completion standards for each lesson.

Grades will be assigned as follows:

PROGRESS POLICY

Satisfactory progress:

Satisfactory progress will be monitored by periodic stage checks and examinations as determined by the course syllabus, graded using the relevant system described earlier, and a cumulative Grade Point Average computed. Students must obtain a cumulative GPA of not less than 2.0 at the end of each course and complete each program within 150% of the normal program time.

Student GPA is calculated at the end of each program course, and a “cumulative GPA” represents an average of all final course grades individual students earned from the time they first enrolled in the School to the completion of their program.

Unsatisfactory Progress

Should a student fail a stage check, remedial instruction must be given before the student will be allowed to attempt the stage check again. At the second attempt, it will only be necessary to retest the specific area of deficiency. Should the student fail at the second attempt, then the student will have to repeat the whole of the stage check following additional instruction. Where a student retakes any stage test, the last grade received will be used to calculate the cumulative GPA.

Whenever the stage check failure or course incompleteness will likely lead to change of the graduation date, the student will be notified accordingly by the Chief Flight Instructor or his/her Assistant.

Failure to obtain a cumulative GPA of not less than 2.0 at the end of each course or to complete the program within 150% of the normal program time will result in placing a student on academic probation, or termination from the program at the sole discretion of the Chief Flight Instructor.

The training program consists of integrated modules or courses. After completion of each course each student is issued an end-of-course certificate and student's transcript is being updated accordingly. Each student is provided a copy of the updated transcript sent by email or in a printed format. Transcripts are to be stored in each student's training folder which is available to students for review.

Upon completion of the program, termination or withdrawal each student is provided with a final copy of the transcript.

It should be noted that the normal time to complete the program may be affected by factors outside of the Pelican's control like weather conditions and does not account for the waiting time due to the availability of FAA examiners.

PROBATION POLICY

Academic Probation Policy

Should a student's cumulative GPA fall to 2.5 or less, but not less than 2.0, an academic warning letter will be sent to the student indicating that they are required to obtain at least a minimum cumulative GPA of 2.0 at the end of each course and failure to do so can result in probation or termination from the program. <p>student will be then invited for an academic review meeting with the Chief Flight Instructor to discuss academic progress.</p> <p>Should the student's cumulative GPA not reach at least 2.0 at the end of any course, an academic probation or termination letter will be sent to the student indicating that since the cumulative GPA at the end of a course is below 2.0 they will be placed on probation or terminated from the program at the sole discretion of Chief Flight Instructor.</p> <p>The Chief Flight Instructor then evaluates such student's progress and academic achievements and develops a probation plan and requirements or makes a decision to terminate the student from the program. Copies of all letters will be placed in the student's training records.</p> <p>In case a student does not demonstrate sufficient commitment to show academic progress within the first course of a program, while no cumulative GPA can yet be established, the same warning, academic probation and/or termination procedures, as stated above, will be followed.</p> <p>If a student has not completed the program within 125% of the normal program time, a warning letter will be sent to the student indicating that failure to complete the program within 150% of the normal program time can lead to termination from the program. If the student has not completed the program within 140% of the normal program time, a second letter will be sent to the student indicating the danger of termination from the program. If the student has not completed the program within 150% of the normal program time the student will be placed on probation or terminated from the program at the sole discretion of Chief Flight Instructor. The Chief Flight Instructor evaluates such student's progress and academic achievements and develops a probation plan and requirements or makes a decision to terminate the student. STUDENT COSTS

GENERAL

An application fee of \$515.00 is required with all applications for admission.

Payment of tuition and training fees is an integral part of the registration process. Registration is accomplished in person at Pelican and may be completed any time before the start of classes.

If a student already owes Pelican for past attendance, then all delinquent charges must be paid before registering for future classes.

Required fees are established by Pelican and are subject to change without notice. A listing of program training fees is contained in the School Catalog provided with all first time mailings to prospective students. Actual costs can vary depending on prior flying experience and the aircraft selected. If different, an Enrollment Agreement specifying program content and detailed costs is provided each student before starting training or payment of tuition.

HOLD HARMLESS

A trainee, guardian and/or guarantor signing an Enrollment Agreement is jointly and severally agreeing to indemnify and hold harmless Pelican, its agents, servants and employees, from and against any and all claims, demands, suits, actions, causes of action, liabilities and judgments (collectively, "Claims") which may arise out of or result from Pelican training provided and are solely the result of negligence of the Trainee. Claims arising after completion of such training are treated as Claims arising during the term of such training.

While the sole occupant of a Pelican aircraft, trainee assumes responsibility in all cases where collision damage is incurred during any ground taxi operation in which the trainee's aircraft is the only moving vehicle and not being towed by a Pelican authorized towing tractor. Furthermore, the trainee agrees to pay for all resulting damages including cost of recovering based on the presentation of an invoice from an authorized repair station as designated by Pelican. Trainee authorizes Pelican to apply any funds on account with Pelican as payment for damages described above. Nothing in this statement shall limit the trainee's liability for any other damages described above.

PAYMENT

Payment and other conditions of each training program are clearly stated in the Enrollment Agreement which includes an allowance to cover the expected costs of required FAA examinations and program supplies, plus \$750.00 as a reserve on account. The \$750.00 reserve on account is for the purpose of insuring the funds are available for any unanticipated expenses that may become apparent during auditing and final accounting of training logs after completion of training.

I. PROFESSIONAL PILOT PROGRAM "A"

PROGRAM DESCRIPTION

To help a student plan aviation training, this section includes some facts about Federal Aviation Administration requirements, Pelican's particular requirements, program hours, and other details that should be considered. The following courses are grouped in a logical sequence according to a curriculum which is in the students' best interest to pursue (i.e. certificate courses, rating courses, and diploma programs). The description for each program and course, generally points out the Certificate, Diploma and Rating qualifications that will be earned; these programs are designed to prepare a student to meet the prerequisites for the issuance of Federal Aviation Administration certificates which are awarded after successful completion of the courses. Practical training might be incorporated as an integral part of the program. The following certificate, diploma programs and graduation awards are available.

<p>Program outlines are based on full-time/part-time participation and assume a student has no prior training or experience. If a student already has flight experience, time and costs can be adjusted according to individual background, flight time and ability. Final determination of credit for previous experience will be given after a credit evaluation by the Chief Instructor.</p> <p>Program costs are based on the number of training hours specified in the following outlines. Flight hours needed to gain FAA flight test piloting proficiency which are in excess of normal program times are charged at current hourly rates.</p> <p>The cost of training may vary based on the airplane flown. For more exact computing, we show in the program description section, which follows the various aircraft which may be available.</p> <p>For each course that requires FAA written and flight testing, there will be extra costs. FAA examiner fees of \$150.00 for each knowledge test are common. Examiner fees range from \$500.00 to \$950.00 for FAA flight tests.</p> <p>All FAA testing fees are set by independent examiners, are outside of Pelican's control and are subject to change.</p> <p>The use of an aircraft to conduct the required flight examination is available from Pelican at current hourly solo rates. Approximately two hours of flight is needed for each flight examination.</p> <p>Duration of training is listed for each course. These estimates are based upon full time participation and assume the student completes the program in very nearly the hours of instruction outlined. Less than full time, daily participation or less than standard progress will likely result in additional course training hours and program duration.</p> <p>It should be noted that the normal time to complete the program may be affected by factors outside of Pelican's control like weather conditions and does not account for the waiting time due to the availability of FAA examiners.</p> <p>Ground school - formal classroom lecture, group presentation and/or individual audio-visual instruction for the purpose of acquiring knowledge of pilot subject areas for background and preparing for an FAA written test.</p> <p>Flight Briefing - pre and post flight discussions to brief the student on flight procedures and lesson objectives, critique performance after each lesson, and introduce the next lesson.</p> <p>Course durations as listed are estimates of the time needed by a full time student to complete training. Actual program duration depends upon individual pilot proficiency and ability. The student's own motivation and self-discipline are factors beyond the control of Pelican.</p> <p>The size of most ground school classes will normally range from 4 to 8 students. Advanced courses and flight instructor classes generally are smaller in size, from 2 to 4 students. Courses are also conducted on an individual basis.</p>
